LIMITED USE DEALER PLATES:

Insurers selling vehicles of a type subject to registration, solely for the purpose of disposing of vehicles acquired as a result of a damage settlement or recovered stolen vehicles acquired as a result of a loss settlement.

Vehicles acquired or repossessed by such persons in exercise of powers or rights granted by lien or title-retention instruments or contracts given as security for loans or purchased money obligations.

Vehicles not owned by special body equipment dealers operated for the purpose of delivery, testing, and demonstration of such vehicles which are in possession of the special body equipment dealer for purposes of attaching a special body.

Manufacturer of new ambulances, rescue, and fire vehicles manufactured and owned by the manufacturer solely for the purpose of transporting, demonstrating, showing, or exhibiting the vehicle.

Owner of a motor truck, truck tractor, road tractor, or motor home that is 25 years old or older who desires to use the vehicle exclusively for exhibition or education purposes at state or county fairs, or at other places where the vehicle may be exhibited for entertainment or educational purposes.

TRAILER DEALER PLATES: Trailer dealer plates shall only be used on vehicles owned by the applicant that are moved on the highways solely for purposes of transporting, testing, and demonstrating, providing the trailer is in the dealer's inventory and is continuously offered for sale at retail. Dealer plates shall not be used on vehicles offered for hire, work, or service vehicles.
