New vehicles at the following:

- "FAIR" means a county fair or scheduled gathering for a pre-determined period of time at a specific location for the exhibition, display, or sale of various wares, products, equipment, produce, or livestock, but not solely vehicles, and sponsored by a person other than a single dealer.
- "VEHICLE SHOW" means a scheduled event conducted for a pre-determined period of time at a specific location for the purpose of displaying at the same time various types, makes, or model of new vehicles, which may be in conjunction with other events or displays, and sponsored by a person other than a single dealer.
- "VEHICLE EXHIBITION" means a scheduled event conducted at a specific location where various types, makes, or models of new vehicles are displayed either at the same time or consecutively in time, and sponsored by a person other than a single dealer.

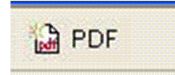
